Dear Collector,

Sub: TNHSP – AB – PMJAY integrated with CMCHIS – Ayushman Card Creation Drive in Tamil Nadu – to facilitate the operators hired by Smart IT Services Private Limited, Common Service Centres, Zephyr Ltd and Third Party Agencies of United India Insurance Company concerned for District level authentication and enrolment – Regd.

As per the G.O Ms. No. 253 of Health & Family Welfare (EAP-1) Department dated 27.08.2022, the Government of Tamil Nadu has issued orders for sharing of beneficiary data of Ayushman Bharat – Pradhan Mantri Jan Arogya Yojana beneficiaries (2.53 Crore) of 77.7 lakh AB – PMJAY families identified from the Chief Minister's Comprehensive Health Insurance Scheme data (1.40 Crore) to the National Health Authority and issuing PVC Ayushman cards to all the beneficiaries in family identified and tagged under AB – PMJAY as per the card design approved in Tamil and English language by the Government of Tamil Nadu.

As per the Govt. Lr. No.20404/EAP-I-1/2022-3, dated 23.09.22 of Health & Family Welfare (EAP -1) Department, the Government permitted the Project Director, TNHSP to engage the Card Creation agencies empanelled by the National Health Authority and Third Party Agencies of United India Insurance Company concerned and also permit the card creation agencies to go on door to door basis and authenticate the beneficiaries using Aadhaar face Authentication or Aadhaar mobile based OTP and issue printed PVC card to all the beneficiaries in the family.

In this regard, the three card creation agencies (CSC's, Smart IT, Zephyr Ltd.) and the Third Party Agencies of United India Insurance Company Ltd will authenticate all the beneficiaries in identified family (77.7 Lakhs families i.e 2.53 Crore individual members of the family) and tagged under AB – PMJAY on a door to door basis using Aadhaar based Face authentication or Aadhaar based mobile OTP and after successful authentication will issue printed Ayushman Bharat – Chief Minister's Comprehensive Health Insurance PVC cards to the beneficiaries. 
